Location

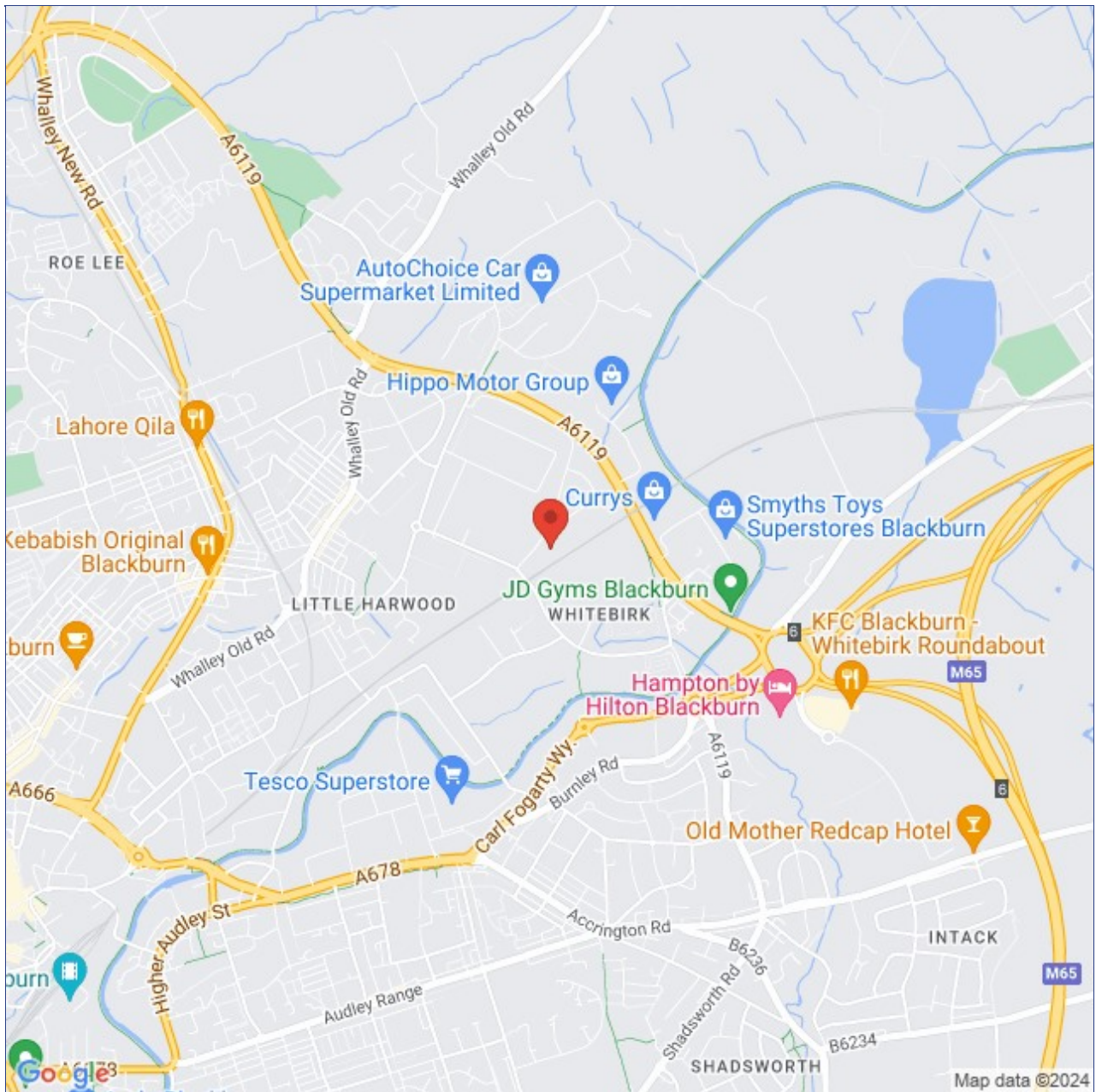
