Location

The premises are prominently situated at the entrance to Hall Moss Business Park which is conveniently located at the top of Bull Hill on the Southern outskirts of Darwen, immediately fronting Bolton Road (A666). See location plan for further details.

Description

The premises comprises 1 semi -detached industrial unit and also a large tarmac yard area extending to 0.23 acres / 10,000 sq ft.

The unit extends to 1,108 sq.ft with access via an electric roller shutter door and insulated cladding to the side elevations making this property suitable for storage or light manufacturing.

All mains services (with the exception of gas) are connected to the property.

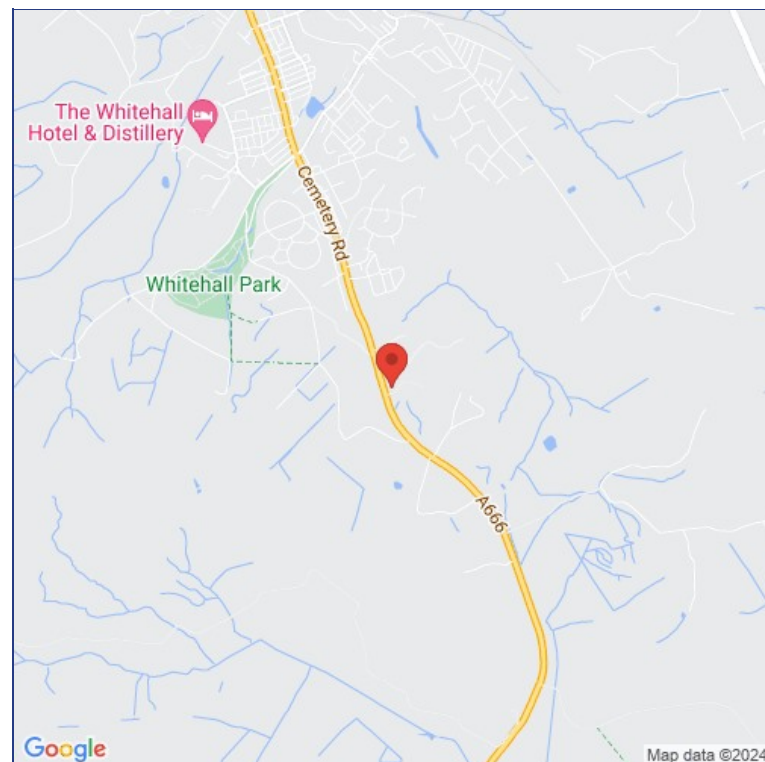
