#### Location

Lune Business Park is located just one mile from the centre of Lancaster, on New Quay Road, adjacent to the River Lune.

Junctions 33 and 34 of the M6 motorway are just a short drive away, along with Lancaster Train Station and also the shipping port of Heysham.

## Description

Lune Business Park is a major new 23 acre development by Hurstwood Holdings, which will comprise a mix of modern industrial units of steel portal frame with 5m to 8m eaves height, insulated profile steel cladding and electrically operated roller shutter doors.

This phase of units will range in size from 10,000 sq.ft up to 50,000 sq.ft with design and build opportunities available, subject to timings.

All units will benefit from allocated car parking and either shared or private gated yard space, making the units suitable for various different uses.


