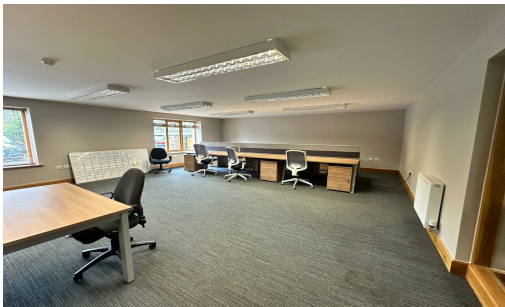

Location
